**Official Minutes-Regular Meeting**  
**April 8, 2022**

**Call to Order/Roll Call**

President Christa Lousberg called the Regular Board Meeting of the Fleming School Board of Education to order at 7:04pm on Friday, April 8, 2022 in the School and Community Library. The following members were present: Karianne Donnelson, Christa Lousberg, Kim Nolde, Shane Schliesser and Carmen Vandembark. Also present were; Kortney Firme-Principal, Amber Schliesser-Business Manager, and Steve McCracken-Superintendent.

**Audience/Open Forum/Correspondence**

Present at the meeting: Becky Harms and Jessica Japp.

**Becky Harms**-Mrs. Harms teaches 6<sup>th</sup>-12<sup>th</sup> grade Social Studies, History, Government, and Psychology. She talked about what she is teaching in her program. She also informed the board that she took the 5<sup>th</sup>-8<sup>th</sup> grade students to Rural Ameri-Towne in Wray. The student learned many different skills including how to use a checkbook and other useful "life skills". They also had to interview for particular jobs before they arrived at the event.

**Jessica Japp** - Mrs. Japp teaches 4<sup>th</sup> grade in Fleming. She is also one of the junior class sponsors this year. She talked with the board about the state assessments and the NWEA testing.

**Kortney Firme- Principal**- Mrs. Firme is 74% complete with transferring our data to ALMA, we are planning to go live June 1<sup>st</sup>. She also shared with the board the results of the teacher surveys in regards to the study skills class. Most teachers are in favor of continuing to offer the class. Mrs. Firme concluded her report by presenting the most recent high school schedule for next year and talking about the measures of student learning we are using in Fleming.

**Steve McCracken- Superintendent**- Construction has started on the new bus barn. Mr. McCracken updated the board on the progress being made on the repairs for 401, it appears to be an electrical issue. Our students are preparing for State FFA CDEs and State FBLA competitions. H. 12- The motion to approve that the Board is operating within the limits of policy GP-5, President's Role was made and seconded. All voted: Motion passed.


H. 13- The motion to approve that the Superintendent is operating within the limits of policy E-3, Student Personal Growth was made and seconded. All voted: Motion passed.
