Grounds for denial of admission to a nonresident student who otherwise complies with the district's policies and procedures are limited to the following:

- a. There is a lack of space or teaching staff in a particular program or school requested, in which case priority will be given to resident students applying for admission to the program or school.
- b. The school does not offer appropriate programs or is not structured or equipped with the necessary facilities to meet special needs of the student or does not offer the particular program requested.
- c. The student does not meet the established eligibility criteria for participating in a particular program including age requirements, course prerequisites and required levels of performance.
- d. The student has been expelled from any school district in the preceding 12 months or is in the process of being expelled.
- e. The student has demonstrated behavior in another school district during the preceding 12 months detrimental to the welfare or safety of other students or of school personnel.
- f. The student has graduated from the 12<sup>th</sup> grade of any school or is in receipt of a document evidencing completion of the equivalent of a secondary curriculum.
